- **Ecotoxicology:** identification of the studies required for regulatory compliance; placement and monitoring of higher-tier, good-laboratory-practice (GLP) compliant studies when required; calculation of predicted, no-effect concentrations from study endpoints and assignment of assessment factors; data gap analysis and evaluation of data quality; data waivers and read-across arguments; interpretation of data packages; and preparation of chemical safety assessments and robust study summaries
- **Toxicology:** derived no-effect level (DNEL) estimation; data gap analysis and evaluation of data quality; data waivers and read-across papers supporting simple and complex substances; interpretation of data packages; preparation of chemical safety and robust study summaries; programme management and study monitoring; and advice on complex study designs and programmes
- **Safety data sheets (SDS) and extended safety data sheets (eSDS):** help with ensuring regulatory compliance and consistency with hazard and exposure information in registration dossiers
- **Classification, Labelling and Packaging (CLP) and Globally Harmonised System (GHS) classification, notification and labelling:** classification of substances and mixtures, notifications and support for product label design
